2. The creditors of **MARG LIMITED**, are hereby called upon to submit their claims with proof **on or before 12th June 2019** to the interim resolution professional at the address mentioned against entry No.10.
3. The financial creditors shall submit their claims with proof by electronic means only. All other creditors may submit the claims with proof in person, by post or by electronic means.
4. The submission of proof of claims is to be made in accordance with Chapter IV of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016. The proof of claims is to be submitted by way of the following specified forms:
 - Form B – For claims by operational creditors other than workman and employees**
 - Form C – For claims by financial creditors**
 - Form CA – For claims by financial creditors in a class**
 - Form D – For claims by workman and employee**
 - Form E – For claims by authorized representatives of workman and employee**
 - Form F – For claims by creditors (other than financial and operational creditors)**
5. A financial creditor belonging to a class, as listed against the entry No. 12, shall indicate its choice of authorised representative from among the three insolvency professionals listed against entry No.13 to act as authorised representative of the class Home Buyers and Deposits in Form CA.
